

2024 48-HOUR FILM CHALLENGE

UPON ENTERING THIS CHALLENGE, YOU AGREE TO THE FOLLOWING RULES:

1. LIABILITY: Filmmaker assumes ALL liability and responsibility while producing their film.

2. HFC MEMBER REQUIREMENT: The filmmaker submitting the film (usually the director, producer, and/or writer), must be a current HFC member. Not all teammates must be HFC members.

3. IN-STATE REQUIREMENT: Film must be produced and filmed in Hawai'i.

4. LENGTH & CREDITS: Film must not exceed 5 minutes including credits. Film title & filmmaker name(s) must be placed at beginning or end of film.

5. CONTENT: This is a family friendly challenge. No extreme violence, gratuitous sex, hurting/killing of animals, etc. We reserve the right to screen films for appropriate content. THINK PG-13!

6. CREATIVE PROCESS: All creative work for the film must take place during the official 48-hour time period. Any creative work in advance of the competition weekend is prohibited. Creative work includes, but is not limited to: Writing the Script, Rehearsing, Costume/Set Design, Shooting, Editing, Sound Design/Soundtrack, Creating Animations, Rendering, etc.

7. PERMITTED PREPARATION: The only work to begin prior to the 48-hours: Organizing equipment and teams, as well as creating your VIMEO/DROPBOX/GOOGLE DRIVE Account (best to do this ahead of time).

8. ALLOWED FOOTAGE: All footage must be shot within the 48-hour time period of the film challenge. Animation and special effects are permitted, but must be created during the 48-hour time period. Still photographs are permitted, provided the filmmaker has rights to them. Still photographs do not need to be taken during the 48-hour time period. Stock/Purchased footage is NOT permitted, as all footage must be shot within the 48-hour time period. Music may be pre-recorded, but may only be used if the filmmaker has the distribution rights to that music.

9. REQUIRED THEME & PROP(S): Required Theme, Props, and Line of Dialogue will be posted on HFC's Facebook, Instagram, and Website on Friday, April 12th, 2024 at 4:00 PM.

10. SAG-AFTRA/UNION TALENT - It is the filmmaker's responsibility to complete a SAG-AFTRA online micro-budget agreement if SAG-AFTRA talent will appear on screen. Application:: https://sagaftra.jotform.com/202966333409054

11. <u>IMPORTANT NEW RULE:</u> You must include our Mandatory Crew & Talent Release (see Page 2) signed by EVERYONE INVOLVED.
